Dear Jan and Amelia,

Thank you for meeting with me on September 24, 2018 for the on-site review of the Marquette County Elderly Nutrition Program. As you know, the nutrition assessment was completed for the 2016-2018 plan assessment period to review all items surrounding the functioning of the nutrition programs under the Older American's Act including the following areas: administrative functions, income sources, congregate nutrition programming, home delivered meal programming, food safety and sanitation, and other nutrition services. I am happy to report that I found your program in compliance with policy and procedures.

Upon my visit to the dining center, I observed the site manager and volunteers practicing proper food safety and sanitation techniques, including ensuring the use of gloves and hairnets while working with food and checking food temperatures to ensure safety. I observed a clean, well-run kitchen and serving area. I found no violations of the Food Code and feel confident that proper food safety and sanitation principles are practiced on an ongoing basis. The food was a proper temperature, tasty and I heard no complaints from the participants. The dining center met my expectations.
